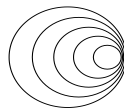

- (2) Application of Rates:

When operating conditions permit, Buckeye Pipe Line Company, L.P. will transfer specified products through its existing manifold facilities to and/or from terminals, refinery tankage, and pipelines of any other company directly connected to Carrier's manifold facilities at the rate shown herein. For transfers in the Toledo, OH area, rate (A) shall apply to transfers of fungible products involving only the Carrier's manifold facilities; rate (B) shall apply to transfers involving its existing mainline pipes; rate (C) shall apply to aviation gasoline and other non-fungible products including any additional barrels of buffer material required to effectuate the movement.

- [N] (3) Toledo BP-Husky / Citgo Transfer Charge

Carrier will transfer products between the BP-Husky Toledo Refinery and the Citgo Toledo Terminal (both in Lucas County, OH) at the rate of 12.90 cents per barrel
