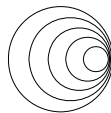

Paulsboro to and from Colonial Junction

Carrier will transport Refined Petroleum Products through its pipeline facilities between Paulsboro and Colonial Pipeline Junction (both in Gloucester County, New Jersey) at the rate of seven and ninety-two hundredths cents (7.92¢) per barrel (42 United States Gallons) when same are moving in interstate commerce.

Paulsboro Terminal Transfer

Carrier will transport Refined Petroleum Products through its pipeline facilities from Paulsboro ST Terminal and Paulsboro Sun Terminal (both in Gloucester County, New Jersey) at the rate of fifteen and thirty-nine hundredths cents (15.39¢) per barrel (42 United States Gallons) when same are moving in interstate commerce.
