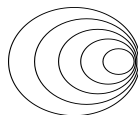

(5) On a monthly basis, each shipper will be charged the base rate for volumes up to 130,000 barrels. On a monthly basis, each shipper will be charged the incentive rate for all volume greater than 130,000 barrels.

(1) The Volume Incentive Rate is available to any shipper subject to the following conditions:

Shipper must agree to transport a minimum of 5,000,000 barrels of product during a twelve month period (contract year).

If a shipper fails to transport at least 5,000,000 barrels during any contract year, a deficiency charge will be applied which will be equal to the then-current incentive rate from Lima to Columbus as documented in Table 2 times the number of barrels deficient.

Incentive rate applies to all barrels moved.
