- Applicable for product delivered from Delaware Pipeline Company LLC.
- Rate applies to any shipper with volumes averaging 250 barrels per day or greater in any calendar month. All volumes physically tendered at this origin will be deemed subject to this Tariff.

Special Products Handling Charge:

A special handling charge of [U] seven and four hundredths cents (7.04¢) per barrel will be added for all unfinished or sub-grade gasolines including Reformulated Gasoline Blend Stock for Oxygen Blending (RBOB) and Conventional Gasoline Blend Stock for Oxygen Blending (CBOB).
